The undersigned applicant hereby applies for membership in SURIGAO DEL SUR I ELECTRIC COOPERATIVE, INC. and in consideration of the acceptance of this application agrees with the cooperative as follows:

1. The applicant will pay to the cooperative the sum of P 5.00 which if this application is accepted by the cooperative will constitute the applicants membership fee.
2. The application will, when electric energy becomes available, purchase from the cooperative all electric energy used on the undersigned premises and will pay therefore monthly rates to be determined from time to time, in accordance with the by-laws of the cooperative.
3. The applicant will cause his premises to be wired in accordance with wiring specifications approved by the cooperative.
4. The applicant will comply with and be bound by the provisions of the charter and by-laws of the cooperative, and such rules and regulations as may from to time be adopted by the cooperative.
5. The applicant, by paying a membership fee and becoming a member, assumes to personal liability or responsibility for any debts or liabilities of the cooperative, and it is expressly understood that under the law his private property is exempt from execution for any debts or liabilities.
6. The undersigned will grant to the cooperative at its request the necessary rights and easement to construct, operate, replace, repair and perpetually maintain my property and in upon all roads, streets or highways adjacent said property, its lines for the transmission or distribution of electric energy, and will execute and deliver to the cooperative any conveyance, grant or instrument which the cooperative shall deem necessary or convenient for the said purposes or any of them. All lines of the cooperative and switches meters and other appliances and equipment constructed or installed by the cooperative on said property shall at all times be the sole property of the cooperative, and the cooperative shall have the rights of access to said property to operate, maintain or relocate its facilities.
7. The cooperative shall not be liable in damages to the applicant for failure to supply electricity to said premises under any condition.

The acceptance of this application by the cooperative shall constitute an agreement between the applicant and Cooperative and the contract for electric services shall continue in force from the date service is made available by the Cooperative to the applicant and thereafter until cancelled by a written notice given at least 30 days by either party.

**AGREEMENT FOR ELECTRIC SERVICE**

The consumer, upon application for electric service hereby agrees to be bound by and to adhere to the Cooperatives policies, rules and regulations, but not limited to the following:

1. Strictly observe or comply all safety rules and regulations in regard to electric service connection;
2. Assumes full responsibility of the kilowatt hour meter installed to his/her premises;
3. Pays electric bill(s) within 8 days from receipt of the notice of collection after which notice of disconnection will follows and reconnection shall be made only after the consumer shall have paid all his outstanding bill(s) including all other fees charges;
4. In case he/she vacates or intend to vacate his/her premises, shall notify the Cooperative of such intention and shall settle all outstanding obligations.  
Furthermore, he/she shall initiate/cause the disconnection of the premises or cause its transfer to the succeeding occupants in order to clear himself/herself from any obligation thereafter.
5. By becoming a member or applying for electric service, he/she willfully agrees to donate the necessary right-of-way easements for the cooperative's electric facilities.
6. Fully agrees/permits the Cooperative or its employees to enter into his/her premise purposely to conduct inspection, evaluation, monitoring, repairs and other related tasks, to all electrical paraphernalia installed specifically kwh meter and service drop;

The Cooperative, in so far as it relates itself to its member/consumers, hereby stipulates as follows:

1. That for as long as the consumer faithfully complies with all existing policies, rules and regulations, shall furnish dependable and efficient electric service on a round-the-clock basis. In case of conflagration, typhoon, earthquake or other natural calamities, causing damaged to its facilities, it shall exercise due diligence to put back the system into operation, and the member-consumer shall be informed of any planned service interruption through any practice means.
2. Upon receipt of any complaint such as regard to billing discourtesy of employees, and other service-related matters shall act to resolve such complaints within (15) days, provided, however, that when the complaints refers to billing, the consumer shall pay the amount under protest and the Cooperative shall make the necessary adjustments as maybe necessary within the period above prescribed.

The consumers and the Cooperative shall endeavor to have an amicable settlement of any claim, conflict, or grievance before resorting to court action. Reference to, and assistance of an arbitrator or board of arbitrators, shall be sought by either who agrees to abide by his/her decision.
